

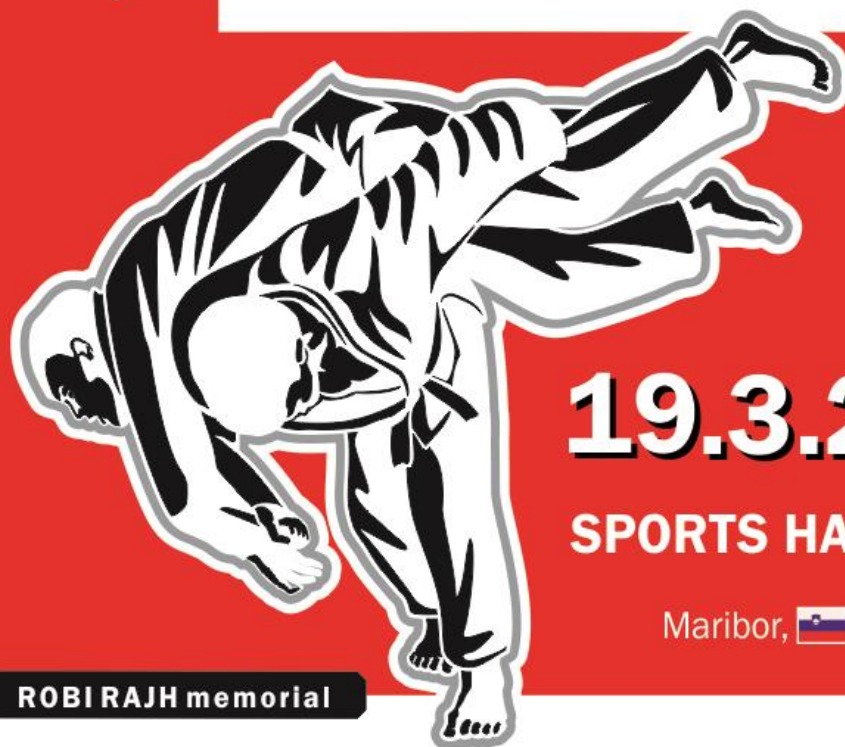

V. COMPETITION RULES

Fighting: Children U14, Cadets U16, Aspirants U18, Juniors U21 and Adults: JJIF Rules – for Children U14 and Cadets U16 previous U15 rules apply

Children (U12): all three parts, no punches to the head, without locks and strangulations, full Ippon possible, the Osae-Komi 10 seconds for Ippon, 6-9 seconds for waza-ari, fight duration 2 minutes

Children (U10): all three parts, no punches to the head, without locks and strangulations, full Ippon possible, the Osae-Komi 10 seconds for Ippon, 6-9 seconds for waza-ari, fight duration 1,5 minute

Ne-waza: Cadets (U14 and U16), Aspirants, Juniors and Seniors: JJIF Rules

Duo-system: Aspirants U18, Juniors U21 and Adults: JJIF Rules (all series by draw)

Children (U16): three (3) attacks from series A, B and C (drawn by the referee for each series!)

Children (U14): three (3) attacks from series A and B (drawn by the referee for each series!)

Children (U12): attacks no. 1, 2 and 3 from series A and 1, 2 and 3 from series B.

Children (U10): attacks no. 1 and 2 from series A and 1 and 2 from series B.

Children (U8): attacks no. 1, 2 and 3 from series A.

Duo Children is also a part of Slovenian National Duo Cup event for children (“Pokal Slovenije”).

VI. RIGHT TO PARTICIPATE

Competitors registered before the deadline: **March 15th**.

Competitors with proper weight and valid personal identification document.

VII. TROPHIES, MEDALS

Gold, silver and bronze medals in each category.

Fair Play Trophy will be awarded for sportsmen like behavior (provided by the JJEU).

VIII. REFEREES

Slovenian and guest referees with valid license. Ju-jitsu Federation of Slovenia shall appoint the Head Referee of the Tournament.

Each team is kindly requested to contribute at least one referee with a valid licence.

XII. ANTI-DOPING

All members should make their competitors aware that there could be a doping control for several athletes. If you are taking any medication or plan to take any medication, please check with your doctor whether your medication contains any substances on WADA's actual Prohibited List published at <https://www.wada-ama.org/en/resources/world-anti-doping-program/prohibited-list-documents>

You will need a Therapeutic Use Exemption (TUE), if it does. JJIF automatically recognizes all TUEs issued by National Anti-Doping Agency (NADAs), so please contact your NADA if you need a TUE and do not already have one. If you have any difficulty in applying for a TUE through your NADA or there is no NADO in your country, please contact the JJIF TUE Committee Director, Mr. Paco Luis Gomez (pacoluisgomez@gmail.com).
